ABOUT EVANS CHRISTIAN OUTFITTERS

In the 1960's Bob and Jewell Evans donated land which became *Camp Francis Asbury*. For many years the camp was owned and maintained by the United Methodist Church. In 2017 the name of the camp was changed to Evans Christian Outfitters (ECHO) and is now owned, operated and maintained by the Friends of Camp Asbury, Inc (FOCA). FOCA operates the summer camps as listed in this brochure but also rents the camp out for groups to enjoy all year long. FOCA is a group of Christian persons who attend various churches in Southeast Ohio and desire to keep the Evans family vision of Christian camping in this region.

CELL PHONE POLICY

Our understanding of modest dress is that which a Christian young person should model in public. It **DOES NOT** include tight, short or revealing clothing. Swimwear for girls must be non-revealing one-piece designed. Camp counselors ultimately determine what is deemed modest.

Evans Christian Outfitters offers a variety of services and voluntary activities designed to enrich the camping experience. Evans Christian Outfitters reserves the right to dismiss my camper if his or her conduct is detrimental to the overall good of the camp at which I am responsible for immediately picking up my camper to return home.
